#### Composition comments

Bentonite contains naturally occurring crystalline silica (not listed in Annex I of Directive 67/548/EEC) in quantities less than 6%. Occupational Exposure Limits for constituents are listed in Section 8. The full text for all R- and H-phrases is displayed in section 16.

## 4. First-aid measures

#### Inhalation

Call a physician if symptoms develop or persist.

#### Skin contact

Therefore, preventing the onset of silicosis will also reduce the cancer risk..." (SCOEL SUM Doc 94-final, June 2003) According to the current state of the art, worker protection against silicosis can be consistently assured by respecting the existing regulatory occupational exposure limits.
